- All payments are immediately due at the end of the Term (N30, N60 etc) unless otherwise agreed in writing and the due date is calculated from the original shipping date. All invoices shall be paid with United States Currency. Applicant/Customer shall pay interest at an annual rate of 12% per year (1% per month) or the maximum rate as allowed by law. Applicant/Customer shall not withhold payment due to claim of offset or counterclaims. A 20% restocking fee applies to all returns and Applicant/customer is responsible for all shipping costs.
- A service charge in the amount of \$35.00 will be charged to the Applicant/Customer for all returned checks or the actual fees charged, whichever is greater.
- In the event that MM FAB, INC. incurs expenses and/or costs, such as fees from collection agencies or attorney's fees, to collect on any invoice, the Applicant/Customer agrees to pay and/or reimburse MM FAB, INC. for all such fees and costs.
- Applicant/Customer agrees that should any dispute arise between Applicant/Customer and MM FAB, INC., the only proper venue to resolve such dispute is in Los Angeles, California and the resolution of such dispute should be resolved by the Superior Court of California, Los Angeles. Further, parties herein specifically waive their rights to resolve their dispute in any federal court. Parties stipulate that the law of the State of California shall be used to resolve any and all disputes.
- Applicant/Customer shall notify MM FAB, INC. of any change of ownership within 10 business days in writing. Applicant/Customer warrants to MM FAB, INC. that all financial and other information furnished for the purpose of obtaining credit is true in all respects and Applicant/Customer specifically authorizes MM FAB, INC. and its affiliates to obtain any necessary information for that purpose any time and as often as necessary.
- Applicant/Customer herein expressly authorize MM FAB, INC., its affiliates, banks and factors to obtain any and all credit reports and / or any equivalent documents for purposes of approving credit from any source.
